CONSTITUTION OF

MOVIE MONDAY SOCIETY

Form 1

1. The name of the society is **MOVIE MONDAY SOCIETY**.
2. The purpose(s) of the Society are:
 - a. to use film/video to provide education about the issues of mental illnesses and recovery;
 - b. to encourage creative expression by providing an avenue to show works, film and otherwise, that is accessible and supportive to artists, especially those marginalized by mental illnesses;
 - c. to encourage understanding of mental illnesses through the use of film/video and to provide outreach to the general public and to individuals and families struggling with mental illnesses by inviting them into Victoria's psychiatric hospital for a positive, educational purpose;
 - d. to develop and advance cooperation between mental health service providers and mental health service consumers, their families and individuals who are living with mental illnesses within the community;
 - e. to provide supportive opportunities for people recovering from mental illnesses to participate in the Society's activities;
 - f. to advance accurate information, and to provide a forum for discussion, on mental health issues and, in particular, to advance such information from the perspective of those who have experienced mental illness;
 - g. to provide our services to the public regardless of income or mental and physical conditions;
 - h. to raise funds in order to carry out the above purposes by means of:
 - i.* solicitation of money from corporations and individuals; and
 - ii.* the carrying on of business activities provided such business are permitted under the *Society Act* from time to time in force and provided such business activities are permitted to a charitable organization under the *Income Tax Act* from time to time in force.

3. In the event of winding-up or dissolution of the Society, funds and assets of the Society remaining after the satisfaction of its debts and liabilities shall be given or transferred to such organization or organizations concerned with the social problems or organizations promoting the same purposes of this Society as may be determined by the members of the Society at the time of winding-up or dissolution, and in effect cannot be given to the aforesaid provisions, then such funds shall be given or transferred to some other organization, provided however that such organization referred to in this paragraph shall be a registered charity recognized by the Department of National Revenue of Canada as being qualified as such under the provisions of the *Income Tax Act* of Canada from time to time in effect.
4. The above purposes of the Society shall be carried out without purpose of gain for its members, and any profits or other accretions to the Society shall be used for promoting its purposes, and all of the above purposes shall be carried on an exclusively charitable basis.
5. No Director shall be remunerated for being or acting as a Director or Officer, but a Director or Officer may be reimbursed for all expenses necessarily and reasonably incurred by him/her while engaged in the affairs of the Society.
6. Paragraphs 3, 4, 5 and 6 of the Constitution are unalterable in accordance with the Society Act.

BYLAWS

The bylaws of the society are those set out in Schedule B to the Society Act.
