TENTATIVE SCHEDULE FOR DEMONSTRATION MARCH 30th AT RIVERVIEW HOSPITAL 10.30 a.m. -part of demonstration leaves Drop-In. Placards and props go out in M.P.A van, and all vehicles going to demo be suitably decorated with posters etc.

- 11.30 a.m. set up skits & demonstrators. Literature distribution starts
- (1) A brightly attired hippie skips along the street mindlessly sniffing flowers. The 'blue meanies'/ Imind police' snatch this harmless creature and carry him off to the 'Provincial mental health facility', where a lobotomy is performed by 'the Doctor', who has a 'fireman' as an assistant. Two people emerge from the 'operation'; one in a grey-flannel business suit carrying a briefcase, walking with a Parkinsonian-type tremor, the other a beat-up looking worn-down individual keeping pace with the first, but crawling alongside him.
- (2) Gerald Budds to dispense 'psychiatric advice (free???)
- (3) Free 'meds' to be handed out (large Smarties sorted according to color)
- (h) A walk-in 'dangerousness' testing machine with a suitable scale (designed by Gerald Beroldi)
- (5) Al Kuensli will appear in a straight-jacket (which will keepcoming undone)
- (6) "pacer syndrome" 2 chairs set up about 30 feet apart, one person sitting in each; every half-minute these persons get up and pace to the opposite chair. This one keeps repeating.
- (7) We have the use of a portable blackboard, but as yet no skit designed around it.

12:00 noon - LUNCH

12:30 p.m. about this time the conference itself should be breaking for lunch and we'd like to hand out literature and talk to the people who are attending it.

1:30 p.m. we'll wrap-up around this time or sooner and go back to Vancouver.

The Mental Patients Rights Committee is organizing printing of leaflets and posters, and contacting people in media about the demonstration and counter-conference, which will also be topic at this Thursday's 'Politics Nite'at M.P.A.
